This book contextualizes two iconic works of American architecture of the twentieth century by tracing the architectural production of American Unitarians from their origins in the early nineteenth century to a building boom in the post-World War II decades. It shows that Unitarians were responsible for numerous important contributions to American architecture in general, and to the ideas of architecture and democracy.

***Vincenzo Scamozzi and the Chorography of Early Modern Architecture.*** Aldershot: Ashgate Publishing, 2014. Re-issued in paperback by Routledge, 2020.

This book examines the theories and most important architectural projects of the last architect of the Italian Renaissance. With a focus on Book Two of his scholarly treatise, *L'Idée dell'Architettura Universale*, it argues that Scamozzi contributed an early theory of “place,” and shows how his projects reflected this orientation. It was the first comprehensive treatment of Scamozzi in the English language, and it challenged the widespread perception that he was merely an imitator of Andrea Palladio.
